

## **REQUIREMENTS FOR THE FAMRI YOUNG CLINICAL SCIENTIST AWARD/ FACULTY AND FELLOW**

### **Grant Policies and Conditions of the Award**

Before applying for an award you must first determine if your institution can agree to the terms of the FAMRI's nonnegotiable, three-party Grant Agreement. Once you have determined that your University can agree to the terms, you may establish a login account at <https://submissions.aibs.org> or you may reach this link from the FAMRI Web site [www.famri.org](http://www.famri.org) under Current and Upcoming Awards. This will enable you to fill out the on-line submission forms for the CIA Award. The RFAs are available in the same location. Please determine from the RFAs if you wish to apply for a faculty YCSA or a fellow YCSA.

Basic Research; Epidemiology; Clinical Trial; Etiology/Pathogenesis; Therapeutic Intervention; Disease Control; Health Outcomes
